Picacho Cemetery Providing Interesting Stories

Sally Kading and her group of volunteers have uncovered dozens of names of people buried in the old Picacho Cemetery now owned by the DACHS. But who were these people? Kading has the group digging for biographical information that might shed some light on the community and its residents.

Luis Rios and Kading made an interesting find when they discovered the tragic end of Juan Marquez, a Picacho resident who was buried in the cemetery on Sept. 18, 1938. According to news stories in the *Las Cruces Sun-News*, Marquez, 85 years old, died all alone in the rugged San Andres Mountains while looking for "his gold mine."

The articles, published on Sept. 17 and 18 at the end of a search for Marquez, make vague reference to a mine he worked occasionally in the mountains. Apparently, some-

time earlier, he had acquired a pony to use as a packhorse for his trip into the mountains. The horse got sick before he got too far and then died when Marquez returned to town.

Marquez then convinced his neighbor, R.P. Arnold, a Picacho farmer, to drive him to the east side of the San Andres and drop him off on Sept. 6. Arnold promised he'd pick up Marquez on the following Tuesday, Sept. 13. Marquez planned to hike to his mine.

Former Dona Ana County sheriff Felipe Lucero reported that he encountered Marquez on Sept. 10, soon after Marquez had left the home of one of the Lucero cowboys on their ranch. Lucero said the man had no water, food or blankets and was concerned for him. He tried to convince him to return. Marquez refused and continued north.

The Missile Range Offers Ranch Tour To DACHS

Gerry Veara and Jim Eckles, under the sponsorship of the White Sands Missile Range Museum, are going to start tours to some of the historic ranches found “uprange.” Most of them are ruins but there are a lot of folks interested in visiting these sites.

To kick off the series of tours, they want to use a small group of DACHS members as guinea pigs to see how it goes. In addition, White Sands security limits the number of vehicles allowed on a tour so, by definition, this will be a small group.

The plan is to go onto the missile range on **Saturday, Jan. 19**, if there are no military missions. The caravan of visitors will be **limited to only five vehicles**.

This is where it gets complicated. White Sands doesn't care how many people are in those vehicles, they want to make sure the number of cars is small enough for the escorts to easily maintain control.

So this is how we are going to do it. We need members with high capacity, high-clearance vehicles to volunteer to drive. Four-wheel drive is not needed. Then, we fill them with as many members as we can. For example, if we have five vehicles each capable of carrying four people in addition to the driver, we'll be able to haul 25 folks on the tour. We figure there are some big old Suburbans and other beasts out there that can haul more than that.

This will probably require a bit of back and forth communication so email is preferred over telephone, especially at this time of year. It also provides a timestamp on when your “reservation” came in for placement on the list. ***He'll take info until Dec. 21.***

If you don't have a big rig but want to go, contact Jim by Dec. 21 and he'll put you on the list. Depending on what we get, he will then ***assign people to those five vehicles based on “first come, first served.”***

Gerry and Jim figure the tour will take pretty much most of the day - probably getting back into Las Cruces mid afternoon. We will drive a couple of hundred miles to see cattle and angora goat ranches on the flats and in Rhodes Canyon.

Each ranch is loaded with hazards that visitors will have to be VERY cautious around. The amount of wire scattered on the ground and number of nails sticking pointed end up is impressive. It will be very easy to get entangled and trip or step on a nail and put it through your shoe - wear heavy shoes, absolutely no sandals. Also, many places are overgrown with weeds and brush - lots of tumbleweeds.

Hopefully this will be just one of many.

Arnold dutifully went to pick up Marquez on Sept. 13 but he never showed up. Arnold sounded the alarm by notifying the sheriff's department. Sheriff Jose Viramontes immediately ordered a search of the mountains and that they were to stay at it until Juan was “found dead or alive,” according to the *Sun-News*.

Deputy Jimmy Giron, an expert tracker was put in charge of the search party. Joining the group were Arnold, one of Marquez's sons-in-law and a few friends and neighbors.

By the publication of the *Sun-News* on Sept. 17, Marquez was still lost and the paper's headlines read, “Fear Aged Miner Dead in Mountains” and “Hope For Life Of Juan Marquez Almost Abandoned.” The paper was right. The search party found

Marquez's body later that day in Mayberry Canyon. He was found lying under a large tree in the canyon about 15 miles north of where Lucero saw him last. There is evidence of decades-old mining activity at the west end of Mayberry with the foundation of at least one cabin still visible today.

In the obituary for Marquez that appeared on Sept. 20, someone speculated that Marquez probably died not long after his encounter with Lucero. This was based on the fact that Marquez's food pail was still full. That meant the body was exposed to the elements for days and explained why it was “badly decomposed.” It also accounts for the fact that Marquez was buried the very afternoon that the search party got his body back to town. It was probably not a good day for the family or the searchers.
