Hawaii, December 7, 1941: From the Perspective of My Baby Book
Recollections of the Beginning of World War II by Mary Lou Pendergrass

My baby book is a bit different than many, and it, coupled with the stories my father and mother told, give a peek into my family's personal account of the Pearl Harbor story. My father talked about it but once or twice in my recollection, but he did contribute his account once to the writing of a book.

I was a toddler on that day when my father, stationed with a PBY squadron at the Kaneohe Naval Air Base on the northeast side of Oahu, was sitting on our front porch early in the morning, having his cup of coffee and contemplating what to do for my mom for their anniversary that day. He said he heard those planes, couldn't see them because they were silhouetted directly into the sun, but they quickly came into view. Almost immediately he realized what those planes were, ran in, got my mom and me into a safe place under the stairwell, jumped into the car, picking up other men who lived in the base housing around us, and drove quickly to the flight line where their PBY's were parked, the men hanging on the running boards.



Those Japanese planes were on their way to Pearl Harbor where our great fleet was anchored. In order to minimize resistance, they struck at the auxiliary bases on the way in, Kaneohe Bay being one. By the time my dad and the men got there, the planes had been strafed and gasoline was everywhere.

Sometime during that day, my mom and other wives got supplies together and took themselves and all the kids into the cane fields nearby, hoping that would be a safe place. In the next day or so, the military found families for us to stay with in homes inland for a few days in fear there would be another attack or even an invasion.

My baby book says that I quickly learned, at 18 months of age, when the air raid sirens sounded, to race to the back door where my stroller, blankets and food waited, ready to go to the shelter.

My mom and I were evacuated in April. Having been told to be ready for the call at any time with no advance notice, suitcases stood open and mostly filled with the essentials for our turn. We would be given only an hour to minimize sabotage chances for the ship. The knock on the door came about midnight and we hastily were taken to the port, with no headlights to attract unwanted attention.

We came back to El Paso and lived with my grandparents for the duration of the war. My baby book recounts that, with Biggs Field being close by, I often ran to an adult as the planes flew over, asking in my baby way, "Theirs or ours?" Being reassured I went back to my play, but with an ear cocked to hear if they were coming closer. If there was no adult to reassure me, I ran and hid under a bed until an adult came to find me.

Fortunately, I have no real recollections of my own of that time, just these stories and perhaps a special understanding of what war must be like for children.... and a special thanks to the men and women fighting for our country and our freedom. I have a terribly sad feeling for the children of our world whose baby books will be filled with other, far worse stories of war in their lives.

BOARD OF DIRECTORS RECOMMENDED
BOARD OF DIRECTORS RECOMMENDED
BY-LAW CHANGES

The DACHS board recommends the following changes to the Society bylaws to improve operations of the Dona Ana County Historical Society:

- 1) Article I Section 3 - the change will give new members who join the Society after the first of November the option of having their dues applied to the next year. Those selecting this option would receive the newsletter and could attend the Banquet at the Member rate, but would not be eligible to vote until the next year and would not receive a free copy of the SNMHR until the next year.
- 2) Article II Section 1 – the change will eliminate a December meeting from the list of regularly scheduled meetings.
- 3) Article III Section 6 – the change will increase the number of elected At-Large Board Members from four to six.
- 4) Article III Section 7 – the change will provide for the City of Las Cruces ex-officio board member to be selected by the City of Las Cruces Museum Administrator subject to approval of the Board.
- 5) Article IV Section 3 – The change will provide for the term of office of the President and Vice-President to be two years rather than one year.
- 6) Article V Section 2 – the change allows the records of the Society to be kept at a place other than the Branigan Cultural Center.
